NOTIFICATION

In exercise of the power conferred by section 31 of National Law University, Tripura Act 2022 the Executive Council of National Law University, Tripura has approved the following guidelines:-

1. Short title, extend and commencement:-

- i) These guidelines may be named as "Guidelines for Domicile quota in B.A.L.L.B. Program in NLUT" (Annexure A).
- ii) "Guidelines for Domicile quota in L.L.M. Program in NLUT" (Annexure B).
- iii) These guidelines shall come into force from the date of issue of notification.

2. Definitions :-

- i) 'NLUT' means National Law University, Tripura.
- ii) 'PRTC' means Permanent Resident of Tripura Certificate issued by the Competent Authority, Govt. of Tripura

3. Revision:-

As per the provision of Sub-section xii of Section 16 of NLU Tripura Act, 2022 the Executive Committee of the University may make necessary revision in the regulations/ guidelines as and when asked for.

4. Interpretation :-

If any question of interpretation of any of the guidelines arises, the decision of the University Administration shall be final.

Guideline for Domicile quota in B.A.L.L.B. Program in NLUT.

- A. Candidate must be a Citizen of India.
- B. Candidate must be a permanent resident of Tripura and either the candidate or his / her parent must have been residing in the state of Tripura continuously for not less than 10(ten) years immediately prior to the date of making application for appearing the NLUT law entrance test. Permanent resident of Tripura certificate (PRTC) issued by the appropriate authority of the candidate/father/mother which one is applicable and must be submitted at the time of counselling failing which may results in the cancellation of reservation under domicile quota.
- C. Children of all India service officers (Manipur Tripura cadre) and children of the State Govt. employee posted outside the Tripura will be eligible for domicile quota irrespective of their stay in Tripura.
- D. In case the candidate is not a permanent resident of Tripura but his/ her parent is an officer/official on deputation to the Govt. of Tripura / officer or officials of the central Govt. working in Tripura and served in Tripura continuously for a period of not less than 03(three) years or more and the candidate have passed or appeared / due to appear at H.S.(+2) examination or equivalent from an institution of Tripura, is eligible for domicile quota.
- E. In case of ward of Ex-service man, either the candidate or his parents must have been staying in Tripura continuously for not less than 05(Five) years immediately prior to the date of making application for appearing in the entrance test conducted by NLUT.
- F. Children of serving defence personnel (Army/Navy/ Air force) hailing from Tripura are also eligible for reservation under domicile quota, provided that their children should have stayed in Tripura continuously for not less than 05(five) years immediately prior to the date of making application for appearing the entrance test conducted by NLUT.
- G. Children of other service cadre officers of Tripura like, Tripura Judicial service, Tripura Civil Service, Tripura Police Service, Tripura Forest Service etc. who are not permanent resident of Tripura but either serving or had served in Tripura continuously for not less than 10 years will be eligible for domicile quota irrespective of their stay in Tripura.

Guideline for Domicile quota in LL.M. program in NLUT.

- A. Candidate must be a Citizen of India.
- B. Candidates must have passed LLB/BALLB/ any other equivalent Exam and fits in to the eligible criteria set by NLUT.
- C. Candidate must be a permanent resident of Tripura and either the candidate or his / her parent must have been residing in the state of Tripura continuously for not less than 10(ten) years immediately prior to the date of making application for appearing the NLUT law entrance test. Permanent resident of Tripura certificate (PRTC) issued by the appropriate authority of the candidate/father /mother which one is applicable and must be submitted at the time of counselling failing which may results in the cancellation of admission under domicile quota.
- D. Children of all India service officers (Manipur Tripura cadre) and children of the State Govt. employee posted outside the Tripura will be eligible for domicile quota irrespective of their prior stay in Tripura.
- E. In case the candidate is not a permanent resident of Tripura but his/ her parent is an officer on deputation to the Govt. of Tripura / officer of the central Govt. working in Tripura and served in Tripura continuously for a period of not less than 03(three) years or more and the candidate has passed or appeared / due to appeared in LLB/BALLB/any other equivalent exam from an institute of Tripura is eligible for domicile quota.
- F. In case of ward of Ex-service man, either the candidate or his parents must have been staying in Tripura continuously for not less than 05(Five) years immediately prior to the date of making application for appearing in the entrance test conducted by NLUT.
- G. Children of serving defence personal (Army/Navy/ Air Force) hailing from Tripura are also eligible for reservation under domicile quota, provided that their children should have stayed in Tripura continuously for not less than 05(five) years immediately prior to the date.of making application for appearing the entrance test conducted by NLUT.
- H. Children of other service cadre officers of Tripura like, Tripura Judicial service, Tripura Civil Service, Tripura Police Service, Tripura Forest Service etc. who are not permanent resident of Tripura but either serving or had served in Tripura continuously for not less than 10 years will be eligible for domicile quota irrespective of their stay in Tripura.
