#### **ADMISSION FEE PAYMENT UPDATE**

Pursuant to the Merit Lists published on the NLU Tripura website dated **July 01, 2024** for Provisionally Selected to Take Admission to NLU Tripura Against the Vacant Seat Notification to the B.A. LL.B. (Hons.) And LL.M. Programs, this Corrigendum is being issued clarifying the **Admission Fee Payment Guidelines and Mode of Payment** which shall be applicable to the candidates who will take admission to the university based on the **three Merit Lists** (Released on **1<sup>st</sup> July, 2<sup>nd</sup> Merit List Due for Release on 8<sup>th</sup> July, 2024 and the 3<sup>rd</sup> Merit List Due for Release on 18<sup>th</sup> July, 2024**). *This shall be in supersession of the payment guidelines mentioned in the Merit Lists published on 1<sup>st</sup> July for admission to the B.A. LL.B. (Hons.) and LL.M. Programs.* The Merit List remains unaltered for compliance and adherence by the selected candidates.
