STEP-BY-STEP GUIDELINES

For Admission to B.A. LL.B. (Hons.) Program For 2024-2025

(Against the Seat Allotment Under CLAT 2024)

Issued by the Office of the Directorate of Admissions

Pursuant to the CLAT 2024 Result, and Allotment of Seat in NLUT under CLAT 2024 (based on First/Second/Third Seat Allotment Lists), candidate who will be allotted NLUT for admission in the Academic Year 2024-2025 for B.A. LL.B. (Hons.) or the LL.M. (One Year) program, such a candidate shall follow the following Step-By-Step Guidelines to proceed with confirming their seat and payment of NLUT's tuition and other fees as applicable.

Step 1: Candidates who have qualified for CLAT 2024 and are allotted NLUT are advised to strictly adhere to the 'Admissions Counselling Calendar' released by CLAT Consortium on December 11, 2023.

Additionally, after the publication of the Fifth and Final Allotment List by CLAT Consortium, NLUT will release its 'Notification of Vacant Seats for UG and PG Programs' on June 03, 2024, with further instructions on www.nlutripura.ac.in

Step 2: NLUT FEE Submission - Candidates who have been allotted NLUT and have exercised the option to 'FREEZE', by paying a Counselling Registration fee of ₹ 30,000/- (for General Candidates) and ₹ 20,000/- (for SC/ST/OBC/BC/EWS/PWD) and Confirmation fee of ₹ 20,000/- to CLAT Office, *are required to pay the first year's Annual Fee for the Academic Year 2024-25 for B.A. LL.B. (Hons.) or the LL.M. (One Year) programme as applicable to NLUT, following the details below:*

FOR B.A. LL.B. (HONS.) PROGRAMME

a) **One Year's Full Fees (Tuition and Other Fees) of INR 1,91,000/-** (One Lakh and Ninety One Thousand) *[With HOSTEL and MESS Facility]*

b) **One Year's Full Fees (Tuition and Other Fees) of INR 1,61,000/-** (One Lakh and Sixty One Thousand) *[Without HOSTEL and MESS Facility]*

Payable after adjustment of Counselling Registration fee of ₹ 30,000/- (for General Candidates) and ₹ 20,000/- (for SC/ST/OBC/BC/EWS/PWD) and Confirmation fee of ₹ 20,000/- already paid to CLAT Office-

- **For SC/ST/OBC/BC/EWS/PWD:** INR 1,21,000/- (One Lakh and Twenty-One Thousand only)

4. Pass Certificate of 10+2/Higher Secondary or equivalent
5. Mark sheet of 5 years or 3 years law course/equivalent
6. Passing Certificate of 5 years or 3 years law course/equivalent
7. Degree Certificate of 5 years or 3 years law course/equivalent
8. Original Transfer Certificate issued by the institution last attended
9. Original Migration Certificate issued by the Board last attended
10. Original Conduct Certificate/Character Certificate issued by the institution last attended
11. Medical Certificate of Fitness of last 15 days from the date of reporting on the NLU Tripura campus
12. Six recent identical colour Passport Size Photographs of the Candidate
13. Two Passport Size Photographs of Parents
14. Two Passport Size Photographs of Local Guardian, if any
15. Original Colour Print out of Admit Card of NLUTAT 2024
16. Aadhaar Card
17. Proof of payment of full Admission Fees to NLU Tripura

18. 18. Domicile / Permanent Resident of Tripura Certificate (PRTC) (applicable only for candidates selected under PRTC/ State of Tripura Domicile Category)
19. 19. Special Category Certificate (applicable only for candidates selected under SC, ST or SAP/PwD Categories)
20. Notarized Anti-Ragging Affidavit by the Candidate and the parents in the format prescribed by the University Grants Commission (UGC) available on NLU Tripura website.

Step 6: Date of reporting, orientation and commencement of classes shall be notified on the university website. Tentatively, the classes for the new academic year of 2024-2025 will commence in the first week of July 2024.
