- **Communicate effectively:** They can articulate their ideas clearly and persuasively, both in written and oral presentations, making a compelling case for their research findings.
- **Innovate and contribute to knowledge:** They can think creatively and outside the box, generating new ideas and contributing to the advancement of their field.
