It analyses the welfare schemes of Scheduled Tribes (STs) by Government of Tripura; further, it will also study the implementation framework of the welfare schemes for the development of the Schedule Tribe population in Tripura. Furthermore, the project will suggest the reformatory guidelines and policy framework to improve the condition of ST and the laws relating to such welfare schemes.
