1. The prescribed qualifications and experience are minimum and the mere fact that a candidate possesses the same will not entitle him / her for being called for interview. The University reserves the right to restrict the candidates to be called for interview to a reasonable number on the basis of qualifications and experience higher than the minimum prescribed; or by any other condition that it may deem fit. Those who are possessing higher qualifications will be given preference in short-listing the candidates. The University may constitute a Screening Committee to scrutinize the applications and short-list the candidates. Call letters for interview will be sent only to the short-listed candidates and no correspondence will be entertained with applicants who are not short-listed.
2. Canvassing in any form on behalf of any candidate will disqualify such a candidate.
3. The Selection Committee may decide its own method of evaluating the performance of the candidates in interview. The University may conduct written test / skill test or seminar / colloquium / mock class as method of selection and there will be shortlisting after every stage.
4. Applications incomplete in any respect shall not be considered at all.
5. No interim queries regarding test / interview / selection will be entertained.
6. The University reserves the right to fill all the positions advertised or fill only some of the positions or not to fill any of the positions.
7. University will make all correspondence only through email.
