



## MEMORANDUM OF UNDERSTANDING

THIS MEMORANDUM OF UNDERSTANDING IS MADE AT NLU Tripura ON THIS  
17 November, Friday OF THE YEAR 2023.

### **BETWEEN**

The National Law University and Judicial Academy, Assam (NLUJA, Assam), Hajo Road, Amingaon, Guwahati- 781031, Assam (India), represented by its Vice Chancellor, **Professor Dr. V.K. Ahuja** (as Head of the Institution) hereinafter referred to as NLUJA which expression shall always include its successors or assignees or any authorized organization claiming any rights through it:

### **AND**

National Law University Tripura represented by its Vice-Chancellor/Director, Professor (Dr.) Yogesh Pratap Singh (as Head of the Institution) hereinafter referred to as NLUT, which expression shall always include its successors or assignees or any authorized organization claiming any rights through it:

In the spirit of friendship and with mutual interest in cooperation, NLUJA and NLUT enter into this Memorandum of Understanding to promote joint educational and Research collaboration and agree as follows

### **A. Objectives**

The objective is to promote collaboration, provide people world experience, and make it easier to advance knowledge through frequent interactions, reciprocity, and mutually beneficial endeavors. NLUJA and NLUT agree:

- To exchange information/research for educational programmes
- To exchange information on teaching, learning material and other literature relevant to their educational and research programmes
- To jointly organize short-term course/training programme/faculty Development programme on topics of mutual interest and to invite other faculties to participate therein
- To jointly organize seminars, conferences, workshops, special lectures on topics of mutual interest and to invite other faculties to participate therein
- To jointly propose and engage in research or training programmes sponsored

by funding agencies, and to invite other faculty to participate therein

- To exchange, on a reciprocal basis, students at Undergraduate, Graduate and Doctoral levels for limited periods of time for purpose of education or research.

### **B. Collaboration**

That the collaborative activities through offline and online mode between the parties hereto may include the following: -

- Certificate/ Diploma courses relating to Law and multidisciplinary subjects
- Allowing Practical training through training programme to teachers, administrative staff and students
- Exchange of faculties, administrative staff and students
- Joint research projects/seminar/conference/workshop through research centers
- Preparing, developing and imparting research input
- Publication and circulation of academic material
- Experts in examination for paper setting, guide, co-guide etc.
- External examiner for PG and UG studies
- Sharing of library resources for students and staff

Provided that, the institutions are permitted to add any other areas which may be identified from time to time by mutual consent.

### **C. Administration**

- Both institutions will designate the person who will have responsibility of coordination and implementation of this MoU
- These activities are to be carried out after mutual consultation between the two parties or the divisions concerned thereof.
- All financial arrangements to pursue any of the above activities are to be consulted and negotiated for each specific case on mutually accepted terms and conditions.
- The two parties agree that, in the event of research collaboration leading to patent rights, copyrights, or other intellectual property rights, a further agreement must be negotiated.

### **D. General Terms and Conditions**

Both the institutions agreed on following general terms and condition for smooth





functioning of MoU and agreed on the following

- Both party after due consultation will agree and organized seminar, workshop, training programme, FDP, Short Term Course etc. as per their convenience and available resources either in offline or online mode
- Each party after consultation will decide the reasonable financial implication for organizing the programme, course, exchange of faculty, staff and students etc. in due course of time
- Each party after due consultation will provide infrastructural, administrative, logistic etc. support for organizing the joint programme or any such activities
- Each party after due consultation will choose the faculty, administrative staff and students for exchange programme
- Any party may withdraw from MoU provided that, no party is allowed to withdraw during ongoing project/programme/workshop/training programme/exchange programme etc.
- Each party agreed that, in the event of disputes between the parties, the same shall be resolved amicably
- Each party after due consultation agreed that, MoU may only be modified or amended by a written document executed by a duly authorized persons.
- Both the parties will take reasonable measures to protect the secrecy of the information received or acquired during operation of the course, practical training/ internship etc.
- All communication relating to course/programme/FDP/Exchange programme etc. will be communicated through mail and letter to respective authority in advance
- The promotion of the collaborative and joint courses/activities will be made through socialnetworking websites, preparation of brochure that will give details about both institutions in the institutional websites.
- That this Memorandum of Understanding is executed in duplicate and one copy will remain with each of the party.
- That this MoU is not legally binding and the Parties acknowledge that this MoU does not place them under any obligation to enter into any subsequent



agreement or arrangement. This MoU is designed to assist and inform the Parties' on-going discussions and neither Party wishes for this MoU to give rise to any binding commitment or legal obligation.

The Parties agree that each shall bear their own costs for any work under this MoU, save and except as separately agreed in writing.

We support and sign this general Memorandum in recognition of our mutual interests.
