NATIONAL LAW UNIVERSITY TRIPURA

CHIEF MINISTER'S VISIT



National Law University, Tripura, successfully conducted a one-day symposium on "Emergency Provisions under the Indian Constitution: Retrospect and Prospects" on July 01, 2024. The Dignitaries present included Hon'ble Chief Minister of Tripura, Professor (Dr.) Manik Saha, Shri Jitendra Kumar Sinha, IAS, Chief Secretary, Shri Raval Hamendra Kumar, IAS, Secretary, Higher Education, and Dr. Pradeep Kumar Chakravarty, IAS, Secretary to the Chief Minister. The symposium initiated with the welcome address by the Vice Chancellor, Prof. (Dr.) Yogesh Pratap Singh followed by Hon'ble Chief Minister's address to the national emergency of 1975 wherein he furnished a good perspective to that historical context and implications that may have emerged in an era. Assistant Professor from DDM College, Khowai, Dr. Pankaj, enriched the discussion with scholarly insights into the complexities of

EXTENSION LECTURES

Advocate Kumar Shailabh, Child Rights Lawyer, HAQ: Center For Child Rights



On August 30, 2024, National Law University, Tripura's Centre for Women and Child Rights hosted a lecture by Adv. Kumar Shailabh, focusing on child rights litigation and the POCSO Act. In his exploration of the POCSO Act's complexities, Adv. Shailabh clarified its provisions and their ramifications for child safety. He emphasized the importance of understanding international child rights standards, which serve as a foundation for safeguarding children's interests globally. The lecture also touched upon the significance of social justice for children, emphasizing the necessity of teamwork to protect their welfare. The POCSO Act defines a child as anyone under 18 years of age and explains forms of Sexual Abuse as Physical and non-physical abuse, which includes penetrative, non-penetrative sexual intercourse, pornography, and online exploitation. The Act requires reporting of all child sexual abuse cases, with penalties for non-compliance. Adv. Shailabh lecture aimed to raise awareness about child rights and the POCSO Act, encouraging participants to become advocates for children's welfare. By sharing practical insights and expertise, the lecture contributed to a deeper understanding of the complexities surrounding child protection and social justice.

Mr. Ashutosh Pandey, Director, Tripura Judicial Academy

Mr. Ashutosh Pandey, Director, Tripura Judicial Academy, presented a special lecture on BNSS, outlining its objectives, scope, and investigative protocols. He covered the investigation process in detail, including FIR registration, evidence collection, interrogation techniques, and arrest procedures. Dr. Ahuja discussed factors influencing bail decisions and recent legal updates. The lecture ended with an engaging Q&A session with students.



Dr. Parikshit Sirohi, Assistant Professor, Faculty of Law, University of Delhi




The Law of Torts constitutes a fundamental course as prescribed by the Bar Council of India's Rules of Legal Education, 2008. This field primarily addresses the redressal of wrongful civil actions through the awarding of damages. National Law University, Tripura has incorporated this subject into the first-year curriculum of the B.A.LL.B(Hons.) program with the objective of familiarizing students with both traditional and evolving concepts of tortious liability. To further enhance this learning experience, a two-day special lecture series was organized featuring Dr. Parikshit Sirohi, Assistant Professor, Faculty of Law, University of Delhi.

This event took place on September 30 and October 1, 2024, at the NLU, Tripura campus. During the lectures, Dr. Sirohi conducted an in-depth discussion on the concepts of strict liability and absolute liability. The seminal case of Rylands v. Fletcher (1868) was analyzed, along with its exceptions, which include damages caused by acts of God, the victim's own fault, or actions undertaken under statutory authority. Additionally, Dr. Sirohi provided an overview of the landmark Indian case, M.C. Mehta v. Union of India (1987), whereby the Supreme Court established pertinent principles in the context of environmental and industrial hazards. These lectures highlighted essential distinctions and presented real-life case studies, effectively illustrating the practical applications of these legal concepts in contemporary legal scenarios.

Dr. Jayanta Ghosh, Assistant Professor of Law, WBNUJS, Kolkata

On October 17, 2024, Dr. Jayanta Ghosh, Assistant Professor of Law at WBNUJS, Kolkata, delivered a special lecture for the LL.M. Programme's Special Lecture Series on Research Methodology at NLU, Tripura. He discussed the multifaceted traits of action research in law, highlighting essential skills and methodologies. Dr. Ghosh illustrated the practical application of action research to real-world legal issues. The session was supervised by Hon'ble Vice-Chancellor Prof. (Dr.) Yogesh Pratap Singh and coordinated by Dr. Bandita Sengupta.




Prof. Ahmed Ali Khan, Former Faculty, National Law University Odisha (NLUO)


GUEST LECTURES

Kesava Rao, Former Vice-Chancellor of National Law Universities in Ranchi and Visakhapatnam. Renowned for his profound knowledge in contract law and legal education, Professor Rao brought the subject to life by diving deep into the intricacies of the Sale of Goods Act and the multifaceted world of standard form contracts.

Professor Rao began his lecture by skillfully outlining the fundamental principles of the Sale of Goods Act. He painted a vivid picture of its application within the realm of commercial transactions, intricately detailing the rights and obligations that bind the parties involved. Additionally, Professor Rao navigated the complex landscape of standard form contracts, illuminating their pervasive presence in contemporary business practices. He meticulously examined both the conveniences they offer and the challenges they pose, using compelling case studies and hypothetical situations to underscore critical aspects that legal professionals must carefully consider when working with such contracts. His insights provided the students with a comprehensive view of the legal intricacies that accompany these commonly used agreements.

By the end of the lecture, students left with a robust foundation in contract law, armed with practical knowledge and insights that they could carry forward into their future careers. The session not only enlightened their understanding but also inspired them to approach the field of law with curiosity and critical thinking.



Hon'ble Dr. Justice Sanjeeb Panigrahi, Judge, High Court of Orissa

On September 21, 2024, Hon'ble Dr. Justice Sanjeeb Panigrahi discussed about Forensic science and its scientific methods and techniques to solve legal issues. In India how Indian Evidence Act, 1872 and Criminal Procedure Code (CrPC), 1973, worked related with forensic laws and forensic evidences. These laws provide a structured framework for the collection, analysis, and admissibility of forensic evidence in courts. He also delivered some insights about how Bhartiya Nyaya Sanhita (BNS), 2023, a comprehensive new criminal law aims to overhaul and update the criminal justice system, including provisions related to the use of forensic evidence.



Prof. (Dr.) R. Siva Prasad, Professor & Head of Department of Anthropology, University of Hyderabad

Prof. (Dr.) R. Siva Prasad, Former Professor & Head of Department, Anthropology, University of Hyderabad graced a special session on Research Methodology from 25th, 26th and 27th September 2024 at the premise of National Law University, Tripura (NLUT). His lecture series covered fundamental and advanced aspects of research methodology, including structure of literature review, formulation of hypothesis, qualitative and quantitative analysis. RESEARCH PROJECTS

"Comprehensive Review of Acts/Rules Administered by the State of Tripura to Simplify,
Decriminalize, and Remove Redundant Laws and to Eliminate the Risk of Imprisonment for
Minor Violations" commissioned by Tripura Institute for Transformation (TIFT),
Government of Tripura





This project was directly aligned with the principles of the Rule of Law and mission of government of India to modernize the legal framework governing the state. By undertaking a detailed review of all laws administered by the State of Tripura, the initiative seeks to enhance regulatory efficiency, reduce unnecessary penal provisions, and foster a citizen-friendly legal environment.

This project represents a critical step towards enhancing the ease of living and doing business in Tripura, fostering public trust in the legal system, and ensuring that the administration of justice remains equitable, efficient, and forward-looking. The project is completed and the report was released by Hon'ble Chief Minister of Tripura Prof. (Dr) Manik Saha on 25 December 2024 while celebrating good governance day in Tripura.

Handholding Support to Panchayats on Preparation of Gram Panchayat Development Plans (GPDP) commissioned by RD (Panchayat) Department, Government of Tripura





The prime objective of this capacity-building initiative is to empower Gram Panchayats of Tripura by equipping their elected representatives with the knowledge, skills, and tools required to effectively formulate and implement the GPDP. The project is still going on and will be completed in the month of March 2025.

Empowering Indigenous Communities: An Analysis of Social Welfare Schemes in Tripura for Scheduled Tribes commissioned by

West Bengal National University of Juridical Sciences (WBNUJS)

This research project aims to understand the demographic profile and various tribal communities in the state of Tripura. It analyses the welfare schemes of Scheduled Tribes (STs) by Government of Tripura. Further, it will also study the implementation framework of the welfare schemes for the development of the Schedule Tribe population in Tripura. Furthermore, the project will suggest the reformatory guidelines and policy framework to improve the condition of ST and the laws relating to such welfare schemes.



The Principal Investigator of this project is Prof. (Dr.) Yogesh Pratap Singh, Vice-Chancellor, National Law University, Tripura and Co-Principal Investigators are Dr. Jayanta Ghosh, Assistant Professor of Law, The W.B. National University of Juridical Sciences, Kolkata and Dr. Debasree Debnath, Assistant Professor of Law, National Law University, Tripura. The Research Associate of the project is Mr. Nehru and Research Assistant is Mr. Subhradip Sharma. The project is still going on and will be completed in the month of April 2025.

"Building a Robust Child Protection Ecosystem in Tripura" commissioned by UNIFCEF Assam

The objective of this project is to understand the nuances of child marriage and to study the socioeconomic factors which are responsible for the child marriages in the state of Tripura. Further, the objective of this project is to identify the preventive measures and good practices taken by the interdepartmental coordination mechanisms to prohibit child marriage in the Dhalai and South Tripura districts. This project will also analyse and identify the schemes of the state government to prohibit the child marriage in the Dhalai and South Tripura districts. The Project Coordinator of this project is Prof. (Dr.) Yogesh Pratap Singh, Vice-Chancellor, National Law University, Tripura and Research Associate is Dr. Debasree Debnath, Assistant Professor of Law, National Law University, Tripura and Research Assistant is Ms. Suchitra Tripura. The project is still going on and will be completed in the month of February 2025.






CONSTITUTION DAY LECTURE

Legal Awareness Camp
