2. The content must be original and should not infringe on any copyright or intellectual property rights.
3. Reels must focus on themes provided by us.
4. NLUT reserves all rights over the submitted reels for promotion or educational purposes.
5. Any form of plagiarism will lead to immediate disqualification.
6. Participants must tag @legalaid.nlut in their Instagram post after receiving approval from the Legal Aid Society.
7. The decision of the judges will be final and binding.

SUB-THEMES

Participants are free to choose sub-themes by their own. The Sub-themes must adhere to the themes provided above.

SUBMISSION GUIDELINES

1. Participants must create an original reel on legal theme or sub-theme provided by us.
2. Single Individual or group of Maximum 3 members are allowed to participate.
3. Participants are free to choose the language i.e. English, Hindi or any other regional language to gain maximum audience reach.
4. The reel must be between 60 seconds to 180 seconds in length.
5. The submission should be made via the Google Form link that will be shared by the Legal Aid Society.
6. After approval from the NLUT Legal Aid Society, participants can share their reels on Instagram in collaboration with the official Instagram handle of NLUT Legal Aid Society.

7. The reel should not contain any inappropriate content; all submissions will be reviewed before approval.
8. Participants must ensure that their reels comply with Instagram's community guidelines.

MARKING CRITERIA

1. Relevance to Legal Theme (20 Marks)

- The reel must address a legal issue or topic related to law and justice.

2. Creativity and Originality (20 Marks)

- Innovative presentation of the legal issue, unique approach, and originality of content.

3. Clarity of Message (15 Marks)

- The reel should clearly communicate the legal issue or concept in a concise manner.

4. Engagement and Impact (15 Marks)

- The reel's ability to engage the audience and create awareness about the legal topic.

5. Technical Quality (15 Marks)

- Visual and audio quality, editing, and overall production standards of the reel.

6. Adherence to Guidelines (10 Marks)

- Compliance with submission rules (length, format, Instagram collaboration, etc.).

7. Use of Legal Aid Society Handle @*legalaid.nlut* (05 Marks)

- Proper tagging and collaboration with the official Instagram handle of NLUT Legal Aid Society.

MARK DEDUCTION

1. Late Submission:

Deduction: 5 marks per 12 hours after the deadline.

2. Non-Adherence to Legal Theme:

Deduction: Up to 10 marks.

3. Exceeding Time Limit (60-180 seconds):

Deduction: 5 marks.

4. Failure to Tag @legalaid.nlut on Instagram:

Deduction: 5 marks.

5. Non-Compliance with Submission Guidelines:

Deduction: Up to 10 marks for incorrect format or incomplete submission.
