The event will be held at the esteemed Tripura Judicial Academy's auditorium on the 23rd and 24th of April 2025, and we warmly invite participation from academic institutions across the state.

It will also emphasize the importance of clarity, precision, and analytical reasoning in every form of legal documentation.

The session on Delimitation of Constituencies will delve into the historical evolution and constitutional framework of delimitation in India. Participants will explore its impact on political representation, electoral fairness, and governance at various levels. Given recent discussions around the 2026 delimitation freeze and its implications, this topic holds significant relevance for scholars of law, political science, and governance.

ABOUT THE SPEAKERS

The sessions will be conducted by Mr. Anshul Dalmia, Research Fellow, Charkha Team and Ms. Mayuri Gupta, Milon K Banerji Senior Resident Fellow, Charkha Team from the Vidhi Centre for Legal Policy. Both are recognized for their scholarly work and field engagement in constitutional law, legal reforms, and policy design. Their sessions are expected to combine theoretical understanding with practical insight, offering students a rich and interactive learning experience.
