CORRIGENDUM TO NOTICE INVITING TENDER [TENDER No. NLUT/TENDER/2025/001]

CONTRACT FOR SECURITY, HOUSEKEEPING, SWEEPING AND CLEANING WORKS IN THE NATIONAL LAW UNIVERSITY, TRIPURA, NARSINGARH, AGARTALA

The National Law University, Tripura, hereby issues this Corrigendum to the Notice Inviting Tender for the "Contract For Security, Housekeeping, Sweeping And Cleaning Works In The National Law University, Tripura, Narsingarh, Agartala", vide TENDER No. NLUT/TENDER/2025/001]. This should be read in addition to the Notice Inviting Tender [TENDER No. NLUT/TENDER/2025/001], issued on June 23, 2025, which is available on the University website

The housekeeping & sweeping personnel which shall be deployed in the NLU Tripura should be as per the requirement given below:-

- A. Housekeeping personnel shall be deployed in one (1) shift of 8 hours as per the breakup below.
 - i. NLU Tripura administrative and academic building: Two (2) in 1 shift.
 - ii. Boys' Hostel: Two (2) in 1 shift.
 - iii. Girls' Hostel: Two (2) in 1 shift.
 - iv. Library Building: Two (2) in 1 shift.

Note1: This is in reference to point/clause no. 3, 'Scope of Housing Works' in the TENDER No. NLUT/TENDER/2025/001.

- B. Sweeping personnel shall be deployed in two (2) shifts of 8 hours each as per the breakup below.
 - i. NLU Tripura administrative and academic building: Four (4) in 2 shifts [Two (2) each shift].
 - ii. Boys' Hostel: Four (4) in 2 shifts [Two (2) each shift].
 - iii. Girls' Hostel: Four (4) in 2 shifts [Two (2) each shift].
 - iv. Library Building: Six (6) in 2 shifts [Three (3) each shift].

Note 2: This is in reference to point/clause no. 4, 'Scope of Cleaning/Sweeping Works' in the TENDER No. NLUT/TENDER/2025/001.

Note 3: A Notification issued by the Labour Department, Govt. of Tripura for payment of Variable Dearness Allowance to the 'Private Security Guard', in force w.e.f. December 7, 2024 is also attached. NOTIFICATION

aforesaid Notification, the State Government hereby revises the Variable Dearness Allowance (VDA) on the basis of 6-monthly average Consumer Price Index Numbers for the period commencing from 01-01-2024 and ending on 30-06-2024. The half yearly average Consumer Price Index is 168 point for different categories of workers engaged in the employment of "Private Security Guard" in Tripura. The Variable Dearness Allowance shall be payable with effect from 01-10-2024 by the employers to the workers/employees employed in the aforesaid employment as per the following schedule:

N.B.:

- a) To arrive at daily rates of wages the monthly rate shall be divided by 26 and the fifty paisa or above rounded off to the next rupee.
- b) The overtime rate shall be the double of the ordinary rates of wages.
- c) The fifty paisa or above rounded off to the next rupee.
- d) The minimum rates of wages are applicable to employees employed by contractors also.
- c) The men and women employees shall get the same rates of wages for the same work or work of similar nature.
- f) The E.P.F. contribution shall be calculated on the monthly minimum rates of wages mentioned herein at Sl.No.6 of the Schedule.
