STEP-BY-STEP GUIDELINES

Date: June 23, 2025

Admission to LL.M Programme For AY 2025-2026

(Against the Seat Allotment Under CLAT 2025)

Issued by the Office of the Directorate of Admissions

Pursuant to the CLAT 2025 Result, and Allotment of Seat in NLUT under CLAT 2025 (based on First, Second and Third Seat Allotment Lists), candidates who have been or will be allotted NLUT for admission in the Academic Year 2025-2026 for LL.M programme, such candidates shall follow the following Step-By-Step Guidelines to proceed with confirming their seat and payment of NLUT's tuition and other fees as applicable.

Step 1:Candidates who have qualified for CLAT 2025 and have been or are allotted NLUT are advised to strictly adhere to the 'Admissions Counselling Calendar' released by CLAT Consortium on May 17, 2025.

Additionally, after the publication of the Third and Final Allotment List by CLAT Consortium, NLUT will release its 'Notification of Vacant Seats for PG Programme' between June 20-27, 2025, with further instructions on www.nlutripura.ac.in

Step 2:NLUT Fee Submission - Candidates who have been or will be allotted NLUT and have exercised the option to 'FREEZE', by paying a Counselling Registration fee of INR 30,000/- (for General Category Candidates) and INR 20,000/- (for SC/ST/OBC/BC/EWS/PWD Category Candidates) and Confirmation fee of INR 20,000/- to CLAT Office, are required to pay the first year's Annual Fee for the Academic Year 2025-26 for the LL.M programme as applicable to NLUT, following the details below:

Step 4: You will receive an e-confirmation from NLU Tripura Director of Admissions Office.

Step 5:Arrange the following documents for physical verification on the day of reporting at NLU Tripura to be notified in due course.

The following documents shall be produced in ORIGINAL on the day of reporting and joining the NLU Tripura campus in person along with one set of photocopies of the documents below-

- 1. Mark sheet of Class 10th / equivalent
- 2. Pass Certificate of Class 10th / equivalent
- 3. Mark sheet of 10+2 / Higher Secondary or equivalent
- 4. Pass Certificate of 10+2/Higher Secondary or equivalent.
- 5. Mark sheet of Bachelor Degree or equivalent.
- 6. Pass Certificate of Bachelor Degree or equivalent.
- 7. Original Transfer Certificate issued by the institution last attended.
- 8. Original Migration Certificate issued by the Board last attended.
- 9. Original Conduct Certificate/Character Certificate issued by the institution last attended.
- 10. Medical Certificate of Fitness of last 15 days from the date of reporting on the NLU Tripura campus.
- 11. Six recent identical colour Passport Size Photographs of the Candidate.
- 12. Two Passport Size Photographs of Parents.
- 13. Two Passport Size Photographs of Local Guardian, if any.
- 14. Original Colour Print out of Admit Card of CLAT 2025.
- 15. Aadhaar Card.
- 16. Proof of payment of full Admission Fees to NLU Tripura.
- 17. Domicile / Permanent Resident of Tripura Certificate (PRTC) (applicable only for candidates selected under PRTC/ State of Tripura Domicile Category).
- 18. Special Category Certificate (applicable only for candidates selected under SC-Tripura, ST-Tripura or SAP/PwD Categories).
- 19. Notarized Anti-Ragging Affidavit by the Candidate and the parents in the format prescribed by the University Grants Commission (UGC), will be shared by the University via email.

Note:

- a) Check the minimum eligibility documents/certificates as applicable for LL.M programme.
- b) The admission shall be provisional in nature subject to verification of related original documents and payment of full applicable fees.

Step 6: Date of reporting, orientation and commencement of classes shall be notified on the University website. Tentatively, the classes for the new academic year of 2025-2026 will commence in the first week of August 2025.
