For Vacant Seat Admission to B.A.LL.B. (Hons.) & LLM. Programme (Based on CLAT 2025 Score for AY 2025-26)

Issued by the Office of the Directorate of Admissions

Pursuant to the MERIT LIST Against VACANT SEATS for Admission to B.A. LL.B. (Hons) and LL.M. programmes for the Academic Year 2025-26, based on the Notifications for Vacant Seats for both the courses, the National Law University, Tripura hereby releases Fee Payment Guidelines For Vacant Seat Admission to B.A.LL.B. (Hons.) & LL.M. Programme.

Step 1: Applicable to Candidates who have been found qualified to take admission to the B.A. LL.B. (Hons) and LL.M. programmes for the Academic Year 2025-26 based on the Publication of Merit List against the Vacant Seats for these programmes.

Step 2: FEES PAYMENT DETAILS

FOR B.A.LL.B. (HONS.) PROGRAMME

- *a)* One Year's Full Payable Fees (Tuition and Other Fees) of INR 1,91,000/- (One Lakh and Ninety One Thousand) *[With HOSTEL Facility]*
- *b)* One Year's Full Payable Fees (Tuition and Other Fees) of INR 1,61,000/- (One Lakh and Sixty One Thousand) *[Without HOSTEL Facility]*

Note: In case of Demand Draft, unless the Demand Draft in original will be deposited in the University, the admission seat will not be confirmed.

Step 6:Arrange the following documents for physical verification on the day of reporting at NLU Tripura to be notified in due course. The following documents shall be produced in ORIGINAL on the day of reporting and joining the NLU Tripura campus in person along with one set of photocopies of the documents below-

- 2. Pass Certificate of Class 10th / equivalent
- 3. Mark sheet of 10+2 / Higher Secondary or equivalent

- 4. Pass Certificate of 10+2/Higher Secondary or equivalent
- 5. Mark sheet of relevant Graduation or equivalent
- 6. Pass Certificate of relevant Graduation or equivalent
- 7. Original Transfer Certificate issued by the institution last attended
- 8. Original Migration Certificate issued by the Board last attended
- 9. Original Conduct Certificate/Character Certificate issued by the institution last attended
- 10. Medical Certificate of Fitness of last 15 days from the date of reporting on the NLU Tripura campus
- 11. Six recent identical colour Passport Size Photographs of the Candidate
- 12. Two Passport Size Photographs of Parents
- 13. Two Passport Size Photographs of Local Guardian, if any
- 14. Original Colour Print out of Admit Card of CLAT 2025
- 15. Aadhaar Card
- 16. Proof of payment of full Admission Fees to NLU Tripura
- 17. Domicile / Permanent Resident of Tripura Certificate (PRTC) (applicable only for candidates selected under PRTC/ State of Tripura Domicile Category)
- 18. Special Category Certificate (applicable only for candidates selected under SC-Tripura, ST-Tripura or SAP/PwD Categories)
- 19. Notarized Anti-Ragging Affidavit by the Candidate and the parents in the format prescribed by the University Grants Commission (UGC), available on the university website.

Note:

- *a)* Check the minimum eligibility documents/certificates as applicable for B.A. LL.B. (Hons.) and LL.M. programmes.
- *b) The admission shall be provisional in nature subject to verification of related original documents and payment of full applicable fees.*

Step 7: Date of reporting, orientation and commencement of classes shall be notified on the university website. Tentatively, the classes for the new academic year of 2025-2026 will commence from August 11, 2025.
