1. The National Law University Tripura invites applications for admission to the LL.M. One Year program against Vacant Seats based CLAT Score 2025. This applies only to the candidates who appeared for CLAT 2025 in December 2024 and have not secured admission in any other National Law University participating in CLAT 2025 Counselling and Admission process.

4. **Hostel Facility:** Kindly note that w.e.f. July 11, 2025, for the AY 2025-26, the hostel facility is available only for the female students who may get admitted to the LL.M. programme (against vacant seats) and are from outside the State of Tripura or outside of the city of Agartala. The hostel facility for the male students who may get admitted to the LL.M. programme (against vacant seats) is no more available for the AY 2025-26. This provision of hostel facility will be applicable only for the students who may be admitted to the LL.M.

programme in. NLU Tripura (against vacant seats), pursuant to this notification. It does not in any way affect the hostel preference given by the students already admitted to NLU Tripura via CLAT Counselling process in either B.A.LL.B. (Hons.) or the LL.M. programme and hostel allotment to such students.

**Admission Process after Filing this Form: The University will publish/declare Three Merits Lists** (as per the schedule below) based on the applications received via Admissions Interest Forms provided above in the Order of Merit considering the CLAT Score 2025 secured the applicants who desire to seek admission against the vacant seats in NLU Tripura. The candidates as per the Merit list will be invited to complete the admission process and deposit the university fees in the Order of Merit, against the number of vacant seats, within a stipulated date, and details given below.

Local students may be allotted hostel accommodation depending on the availability of rooms after allotment of rooms to the students who are not residents of Agartala. In case of limited number of hostel seats, preference will be given to the female students from outside Tripura.*
