National Law University Tripura offers one-year LL.M. Degree Programme for students committed to make career in law teaching. The University offers LL.M. (one year) programme with specializations in Constitutional Law.

The Course comprises 03 Foundation/Compulsory Papers (three credits each), 06 Optional/Specialization Papers (two credits each) to be notified in each semester and Dissertation (3 credits).

Educational Qualification for Admission to P. G. Programme:

- LL.B. degree/equivalent degree in law from a recognized University, with not less than 50% marks (45% in case of SC/ST students)
- Candidate appearing in the qualifying examination can appear provisionally, subject to the production of necessary qualification papers before or at the time of admission.
