OVERVIEW OF PH.D. DOCTORAL DEGREE PROGRAMME

*(Coursework, stages of Ph.D. progress)*

As part of the Ph.D. programme, the enrolled Ph.D. scholars shall submit their Ph.D. thesis within a maximum period of six years. **3 years is the minimum period required for completion of the Ph.D. work for the award of degree.** That is, a Ph.D. Scholar cannot submit a Ph.D. Thesis for evaluation in less than a period of 36 months from the date of enrolment in the Ph.D. program, in keeping with the requirement of the UGC Regulations.

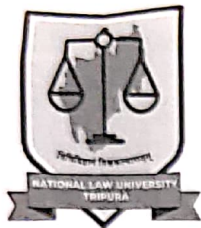
