The National Law University, Tripura hereby closed the admissions to the B.A.LL.B. (Hons.) programme vide Notification dated August 14, 2025, however, few seats have fallen vacant thereafter, hence the University has decided to reopen admission to complete the intake for the programme. Accordingly, the National Law University, Tripura hereby releases the 4<sup>th</sup> Merit List in reference to the applications received for admission to the B.A.LL.B. (Hons.) programme against the vacant seat advertisement published on the university website on June 30,2025. The University releases the merit list separately for the applicants belonging to the general category, PRTC (Domicile of Tripura), SC of Tripura and ST of Tripura.

The reservation category is applicable only to the PRTC (Domicile of Tripura), Scheduled Tribes and Scheduled Castes of Tripura, PWD, pursuant to the state's law and already mentioned in the admission brochure of NLU Tripura and available on Consortium of NLUs (<a href="https://consortiumofnlus.ac.in/clat-2025/nlus/brochure/NLUT.pdf">https://consortiumofnlus.ac.in/clat-2025/nlus/brochure/NLUT.pdf</a>). Candidates belonging to SC and ST (outside the state of Tripura, domiciles of other states, OBC and any other categories) fall under the general category, pursuant to the category-wise intake applicable for admission to NLU Tripura in B.A.LL.B.(Hons.) programme.

- 2. Hostel Facility: Kindly note that w.e.f. July 11, 2025, for the AY 2025-26, the hostel facility is available only for the female students who may get admitted to the B.A.LL.B (Hons.) programme (against vacant seats) and are from outside the State of Tripura or outside of the city of Agartala.

The hostel facility for the male students who may get admitted to the B.A.LL.B (Hons.) programme (against vacant seats) is no longer available for the AY 2025-26. This provision of hostel facility will be applicable only for the students who may be admitted to the B.A.LL.B (Hons.) programme in NLU Tripura (against vacant seats), pursuant to this notification. It does not in any way affect the hostel preference given by the students already admitted to NLU Tripura via CLAT Counselling process in either B.A.LL.B. (Hons.) or the LL.M. programme and hostel allotment to such students.

- 3. In case of any discrepancy found with regard to the payment of application fees of INR 1500/- against the vacant seat application or the certificates submitted by the applicants, the university shall reserve the right to contact the applicant to clarify or resolve the issue and in the event of the applicant not meeting the minimum qualifications criteria, the university shall reserve the right to not admit the candidate to the applied course.
