




Mr. Ashutosh Pandey, Director, Tripura Judicial Academy Conducted Classes on Hindu Law of Succession

The Act has undergone significant change with the Hindu Succession (Amendment) Act, 2005, granting equal rights to daughters. Mr. Pandey also discussed about the Class I, II, Agnates and Cognates with suitable judicial pronouncements and illustrations.

The Memorandum of Understanding (MoU) enhances interdisciplinary research, promotes knowledge exchange, and facilitates collaborative academic programs within law and forensic science. Key areas of collaboration under this MoU include:

- Development of joint certificate, diploma, and degree programs;
- Exchange of faculty and research scholars for knowledge-sharing initiatives;
- Organization of workshops, seminars, and conferences on forensic law and criminal justice;
- Joint research projects focusing on contemporary legal and forensic challenges;
- Internship and training programs for students of forensic science and legal institutions.

Workshops and Seminars

State-Level Multi-Stakeholder Dialogue on Effective Implementation of Child Specific Legislations



The Centre for Woman and Child Rights (CWCR), National Law University Tripura in collaboration with UNICEF conducted a State-Level Multi-Stakeholder Dialogue on Effective Implementation of Child Specific Legislations on January 10, 2025. The event featured Mr. Saju Vaheed A., District Magistrate and Collector of Dhalai, Tripura. He addressed the persistent challenges related to the safety, education, and welfare of women and girl children in the backward regions of the state. Despite the presence of various government policies, issues such as school dropouts and child marriages remain prevalent. In response, Mr. Vaheed has initiated the Balika Manch Program, a proactive initiative that monitors school attendance among girl children. Under this program, if a girl is absent from the school for more than seven consecutive days, designated officer's conduct inquiries to ascertain the reasons, and in cases of economic hardship, necessary governmental support is extended. The program also includes targeted measures to prevent child marriages, thereby promoting the broader goals of education, empowerment, and protection of girl children in Tripura.





The National Law University Tripura (NLUT), in collaboration with the Rural Development (RD) Panchayat Department, Government of Tripura, hosted a one-day workshop to review the Gram Panchayat Development Plan (GPDP) on January 10, 2025. The workshop was held at the State Panchayat Resource Centre (SPRC), A.D. Nagar, Champer Bazar. The workshop was attended by 495 Panchayat secretaries from West Tripura, Gomati, and Sepahijala districts. The workshop was led by Prof. (Dr.) Yogesh Pratap Singh, Vice-Chancellor, NLUT and Mr. Prasun De, Director, RD Panchayat. The workshop aimed to address the grassroots challenges of panchayats and provide innovative solutions for sustainable rural development. There were experts and mentors present who provided feedback and strategies on GPDPs to achieve Local Sustainable Development Goals (LSDGs).







NLUT organized a five-day online workshop on Dissertation Writing for LL.M. students from February 10 to 14, 2025. The workshop aimed to equip postgraduate law students with essential research and writing skills necessary for academic dissertation work. Dr. Parikshet Sirohi, Assistant Professor, Faculty of Law, University of Delhi, delivered the expert sessions during the workshop. He extensively guided the students on how to formulate a synopsis for their dissertations, covering the conceptual framework and structure necessary for a strong research proposal. Dr. Parikshet also introduced the students to the fundamentals of legal research methodology, focusing on the formulation of research problems, objectives, hypotheses, and literature review. A key highlight of the sessions was the in-depth discussion on formatting guidelines, citation standards, and the proper use of footnotes, which are crucial for academic writing in law. The sessions were interactive and insightful, offering practical advice to help students enhance the quality of their research work. The workshop was efficiently coordinated by Dr. Jayanta Dhar, Faculty Member at the NLUT whose support ensured the smooth execution of the program. Overall, the workshop was a valuable academic experience for all participants. It strengthened the foundational knowledge of research writing and encouraged scholarly engagement with the dissertation process.





NLUT hosted a significant discourse on "Viksit Northeast Bharat @2047: An Agenda for Swadeshi and Swavlambi Samridhh Purvottar," a special lecture organized by its Center for Northeast Studies and Policy Research (CNESPR) on February 20, 2025 bringing together academics, policymakers, and students to envision a developed Northeast India by 2047. Dr. Deepak Sharma, Registrar of Tripura University, delivered the keynote address, emphasizing India's rich heritage and the untapped potential of the Northeast region in achieving the national "Viksit Bharat" mission, while passionately advocating for a growth-oriented mind-set among the youth, urging them towards entrepreneurship and embracing self-reliance "Swavlambi" through indigenous solutions "Swadeshi". Professor (Dr.) Yogesh Pratap Singh, Vice-Chancellor of NLUT, further highlighted the crucial role of the region's young minds in shaping India's future.

Introductory Sessions on Career in Public Policy

NLUT hosted engaging introductory sessions on Diverse Legal Fields and Career Pathways in Public Policy on March 06, 2025. Committed to providing its students with comprehensive insights into the vast landscape of legal careers and beyond, the NLUT organized a series of introductory sessions that delved into various specialized areas of law, coupled with a dedicated session exploring the increasingly significant career avenues within public policy. These interactive sessions, aimed to broaden students understanding of potential professional trajectories beyond traditional legal practice, highlighting the interdisciplinary nature of law and the impactful roles legal professionals can play in shaping public policy, thus equipping them with a broader perspective as they navigate their academic and future career choices.







On April 23, 2025, Kautliya Society organized a workshop in collaboration with Vidhi Centre for Legal Policy. The workshop was led by Ms. Mayuri Gupta, Milon K. Banerji, Senior Resident at Charkha, and Mr. Anshul Dalmia, Research Fellow at Charkha, unpacked the hidden crisis of electoral boundaries and representation gaps. The topics covered were:

- The 84th Constitutional Amendment and the 1971 census;
- Risks of gerrymandering, SC/ST dilution, and federal tension;
- Real-time simulations and data-driven analysis; and
- Emerging North-South representation imbalance;

One-Day Workshop on Legal Writing

On April 24, 2025 during the workshop, the participants delved into the intricacies of legal writing, with a particular emphasis on academic compositions and the art of memorial drafting. The session introduced the ILAC method, an essential framework for structuring legal arguments, enabling attendees to approach complex issues systematically. Then the workshop further explored techniques for crafting persuasive and logically coherent memorials, ensuring that participants understood how to present their arguments effectively and convincingly. Additionally, the workshop aimed to bridge the often-perceived divide between theoretical knowledge gained in the classroom and the practical application of these principles in a courtroom setting, providing valuable insights for budding legal professionals.







On April 26, 2025, NLUT hosted a Dissemination Workshop on the Situation Analysis and State Plan of Action for Ending Child Marriages in Tripura. The workshop brought together legal scholars, policymakers, and civil society representatives to discuss recent findings and actionable strategies to combat child marriage in the state. Emphasis was placed on education, community awareness, and enforcement of existing laws. The event highlighted the importance of collaborative, multi-sectorial responses in addressing deep-rooted social issues. Through this event, the students gained valuable exposure to real-world policy work and legal activism. The workshop reaffirmed NLUT's commitment to using legal education as a tool for social change and child rights advocacy.



Two-Days Workshop on Police Investigation, Arrest, Bail and Police Discretion by Dr. Satyajit Mohanty, IPS (Retd.) Former DGP, Odisha



The Centre for Criminal Justice and Human Rights at NLUT hosted an intensive two-days workshop on May 06–07, 2025, focusing on critical aspects of criminal procedure and police practices. The workshop was led by Dr. Satyajit Mohanty, IPS (Retd.), former Director General of Police, Odisha, and currently Adjunct Professor at NLU Odisha, whose vast experience in law enforcement brought deep insights into the complexities of police investigation, arrest procedures, bail jurisprudence, and the exercise of police discretion. Through a structured and comprehensive exploration of key modules, participants engaged with topics ranging from the technicalities of evidence collection and custodial protocols to broader issues of police reforms and the rights of arrested individuals. The sessions encouraged dynamic interaction and practical understanding, enriching students and faculty's academic and professional outlook. Certificates were awarded upon completion, acknowledging the participants' commitment to deepening their knowledge of criminal justice processes. The workshop was proficiently coordinated by Dr. Jayanta Dhar, Assistant Professor of Law and Director of the Centre for Criminal Justice and Human Rights.





On May 23, 2025, the National Law University, Tripura in association with the Voluntary Health Association of Tripura (VHAT), hosted a State-Level Multi-Stakeholders Workshop on Tobacco Control at its Narsingarh campus. The workshop brought together key representatives from the health and education sectors, law enforcement and civil society, academia, and youth organizations to deliberate on strategies for strengthening tobacco control efforts across the state. The inaugural session featured addresses by prominent dignitaries including Smt. Kalyani Saha Roy, Hon'ble Chief Whip of the Tripura Legislative Assembly, alongside senior administrative and health officials. Technical sessions explored the enforcement of COTPA, 2003, the implementation of TOEFI guidelines in educational institutions and the role of local governance. With rich discussions led by experts and practitioners, the workshop concluded on a strong note of collaboration, resolving to enhance coordination among stakeholders and pursue sustained legal, policy, and awareness-driven interventions for a tobacco-free Tripura.

During the session, Prof. (Dr.) Kumar in-depth exploration of provided components of the research essential process, including the development of a research plan, coherent effective formulation of research problems, and mastery of referencing styles. Through a blend of theoretical insights and practical exercises, the workshop offered scholars a structured framework to navigate the complexities of legal research, laying a strong foundation for their doctoral journey.



Prof. (Dr.) Sarfaraz Ahmed Khan, Professor, WBNUJS, Kolkata conducted classes on Hypothesis Formulation and Legal Methods

National Law University Tripura had the privilege of hosting Prof. (Dr.) Sarfaraz Ahmed Khan, Professor at the West Bengal National University of Juridical Sciences, for a focused research workshop aimed at strengthening the academic foundations of its doctoral scholars. Prof. (Dr.) Khan's sessions offered a meticulous understanding of research methodology, guiding participants through the principles of legal inquiry, the formulation of precise and researchable hypotheses, and the application of different legal methods. Furthermore, Prof. Khan encouraged scholars to approach legal research with analytical precision and intellectual curiosity, equipping them with the essential tools for producing meaningful and methodologically sound research output.



Getting Started: A Workshop with Doctoral Candidates of NLUT by Prof. (Dr.) Amita Dhanda

Prof. (Dr.) Amita Dhanda, a distinguished legal academician known for her expertise in legal theory, law and poverty, and rights-based approaches to exclusion and inclusion, conducted a three-day workshop with the doctoral scholars of National Law University Tripura. Her sessions, held from May 28 to 30, 2025, offered a deeply engaging and reflective experience. The first session initiated a conversation on "Why do I wish to do a Ph.D.?". Encouraging scholars to introspect on their research motivations, the personal connect with their topics, and the risk of personal biases affecting academic rigour. On the second day, Prof. Dhanda delved into the nature and function of theory, enabling scholars to critically engage with theoretical frameworks relevant to their individual theses. The final day was dedicated to the Review of Literature, where she clarified the distinctions between methods and methodology, helped scholars identify research gaps, and guided them in articulating their research objectives. The workshop was intellectually stimulating and proved invaluable in strengthening the research foundations of the participating scholars.



Prof. (Dr.) Nachiketa Mittal, Registrar (I/C), NLUT Engages NLUT Doctoral Scholars

As part of the on-going Ph.D. coursework, scholars had the privilege of attending two intellectually stimulating sessions led by Prof. (Dr.) Mittal on June 02-03, 2025. These sessions were thoughtfully crafted to shift the scholars' approach from passive reading to active academic engagement. His core objective was to inculcate in them the ability to think critically, engage with complex texts, and articulate their own original ideas through structured writing. To facilitate this, Prof. (Dr.) Mittal selected three different readings for the scholars — all centred around a common theme and assigned them prior to the sessions. This multi-textual approach enabled the scholars to compare perspectives, understand the nuances of legal discourse, and reflect on the evolution of thought within a particular area of law.



Prof. (Dr.) Indraneel Bhowmick, Professor of Economics, Department of Economics, Tripura University conducted classes on Research Design

Prof. (Dr.) Indraneel Bhowmick, a distinguished faculty member from the Department of Economics at Tripura University, conducted two engaging and insightful lecture sessions on Research Designs and Data. In the first session dated June 04, 2025, he laid a foundational understanding of research design, explaining it as the strategic blueprint guiding a study from its purpose and scope to its data collection and analytical framework. He elaborated on various types of research designs such as case studies, causal, cohort, correlation, cross-sectional, descriptive, diagnostic, experimental, exploratory, field research, longitudinal, mixed methods, and observational designs highlighting their strengths, limitations, and applicability in different contexts. The second session on June 05, 2025 focused on the nature of data, addressing the distinctions between quantitative and qualitative data, the processes and challenges of data collection, and the factors influencing the choice of survey designs like cross-sectional, trend, cohort, and panel surveys. Collectively, the sessions offered a comprehensive and practical orientation to research methodology, equipping participants with critical tools for academic and empirical research.



Prof. (Dr.) Yogesh Pratap Singh, Vice-Chancellor, NLUT conducted classes on Engaging with Constitution with Legal and Interdisciplinary Research

As part of the Ph.D. coursework, scholars had the honour of attending a thought-provoking session led by Prof. (Dr.) Yogesh Pratap Singh, Vice-Chancellor, NLUT on June 06, 2025, on the topic s "Engaging with the Constitution in Legal and Interdisciplinary Research." The session was a compelling exploration of how the Constitution continues to serve as both a foundational document and a dynamic framework for legal inquiry and critique. Prof. Singh emphasized the critical importance of understanding the constitutional grounds on which laws can be challenged — including principles such as equality, reasonableness, and due process. He encouraged scholars to approach legal research not merely as an academic exercise, but as a responsibility that requires a balance between intellectual honesty and constitutional fidelity. He reminded the scholars that while the law permits liberty in interpretation and argumentation, such liberty must be exercised with scholarly integrity, clarity of thought, and a sense of accountability to the public interest. His insights served as a reminder that legal research, particularly at the doctoral level, must aim to contribute constructively to the evolution of law and justice. Throughout the session, Prof. Singh engaged the scholars in dialogue, asking them to reflect on the lived realities of constitutional rights and their relevance in shaping research questions. He also recommended key texts and authors for further reading, thereby offering the scholars a curated intellectual roadmap to deepen their understanding of constitutional thought and its intersections with contemporary legal issues. Overall, the session was a master class in constitutional engagement, leaving the scholars with not only sharper tools for legal research but also a deeper appreciation of the Constitution as a living, and evolving document.

Visit of Hon'ble Mr. Justice Akil Kureshi, Former Chief Justice, High Court of Tripura



A standout moment was the performance of a nukkad natak (street play) on domestic violence by members of the Legal Aid Society. The impactful performance struck a chord with the audience and effectively conveyed the message of resistance and legal empowerment. The session encouraged active participation and dialogue, allowing villagers to engage directly with legal concepts and clarify their doubts. Attendees appreciated the initiative and acknowledged its relevance in their daily lives. In her closing remarks, Ms. Jamatia stressed the importance of legal literacy in advancing gender justice and achieving meaningful equality. The event reaffirmed the Legal Aid Society's commitment to promoting access to justice at the grassroots level.





NLUT successfully conducted the 8th edition of its School Connect Programme at Bodhjung Higher Secondary School, Agartala, on May 07, 2025, as part of its ongoing commitment to community engagement and legal literacy. 
