STEP-BY-STEP GUIDELINES

For Admission to B.A.LL.B. (Hons.) & LL.M. Programme

For AY 2026-2027

(Against the Seat Allotment Under CLAT 2026)

Issued by the Office of the Directorate of Admissions

Pursuant to the CLAT 2026 Result, and Allotment of Seat in NLU Tripura under CLAT 2026 Counselling process, candidates who have been or will be allotted NLU Tripura for admission in the Academic Year 2026-2027 for B.A.LL.B. (Hons.) programme, such candidates shall follow the following Step-By-Step Guidelines to proceed with confirming their seat and payment of NLU Tripura's tuition and other fees as applicable.

Step 1: Candidates who have qualified for CLAT 2026 and have been or are allotted NLU Tripura are advised to strictly adhere to the 'Admissions Counselling Calendar' released by CLAT Consortium from time to time.

Additionally, after the publication of all allotment lists by CLAT Consortium, NLU Tripura will release its 'Notification of Vacant Seats for UG Programme' between in the month of June 2026 with further instructions on the University website www.nlutripura.ac.in

Step 2: NLU Tripura FEE Submission-*Candidates who have been or will be allotted NLU Tripura and have exercised the option to 'FREEZE'*, by paying a Counselling Registration fee of INR 30,000/- (for General Category Candidates) and INR 20,000/- (for SC/ST/OBC/BC/EWS/PWD Category Candidates) and Confirmation fee of INR 20,000/- to CLAT Office, **are required to pay the first year's Annual Fee for the Academic Year 2026-27 for B.A.LL.B. (Hons.) and LL.M. programmes as applicable to NLU Tripura, following the details below:**

FOR B.A.LL.B. (HONS.) PROGRAMME

a) **One Year's Full Fees (Tuition and Other Fees) of INR 1,91,000/-** (One Lakh and Ninety One Thousand) *[With HOSTEL Facility]*
